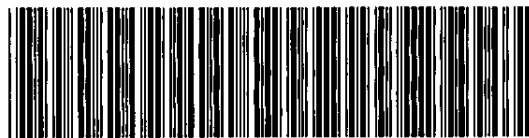


BY THESE ARTICLES OF ORGANIZATION the incorporator forms a Limited Liability Company for profit under Florida law.





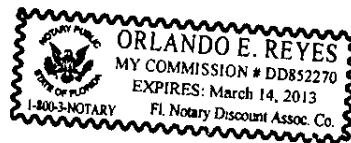
