BIZLOGIX, L.L.C.

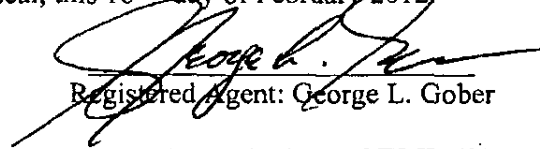
**ARTICLE II-ADDRESS**

**ARTICLE V-PURPOSE**

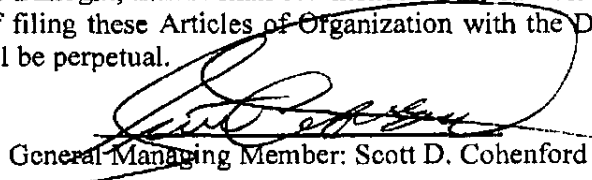
