NAME

The name of this corporation is DB 153 Corporation

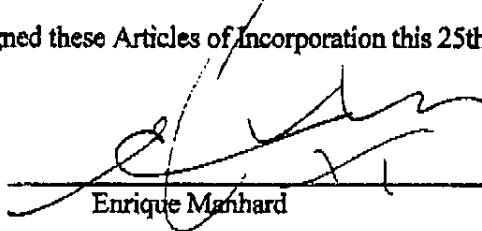
ARTICLE X

CERTIFICATE OF DESIGNATION

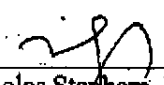
REGISTERED AGENT/REGISTERED OFFICE
