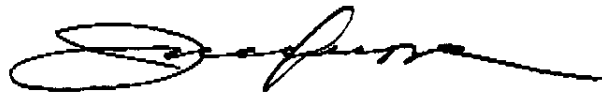

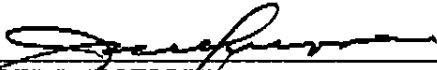
ARTICLE VIII - Management of Corporation by Stockholders

ARTICLE IX - Amendment

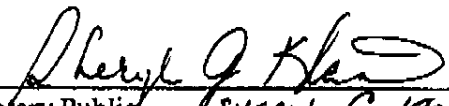
