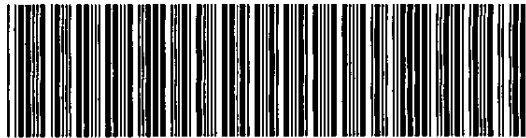

The undersigned, whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, do hereby certify:

ARTICLE I

NAME/REGISTERED OFFICE

The name of the Corporation shall be: **Grupo Misionero Bereia Inc.**

ARTICLE II

PURPOSE

This Corporation is organized exclusively for charitable, religious and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

ARTICLE III

MEMBERSHIP/BOARD OF DIRECTORS

EXEMPTION REQUIREMENTS

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to the benefit of its members, trustees, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in article third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf or in opposition to any candidate for public office. Notwithstanding any other provisions of these articles, This Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in the furtherance of the purposes of this Corporation.

ARTICLE VII DISSOLUTION

Upon the **dissolution of the Corporation**, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the internal revenue Code or the corresponding section of any future federal tax code, or shall be distributed to the

federal government, or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


