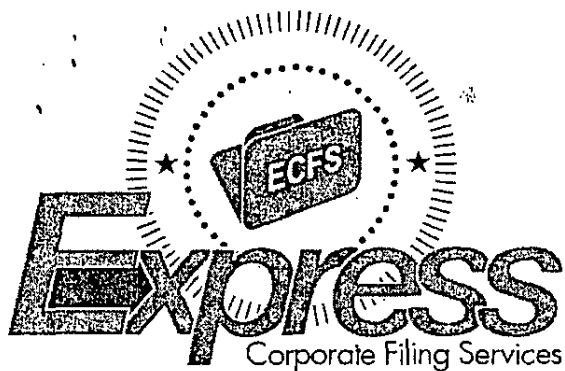

Article IX


