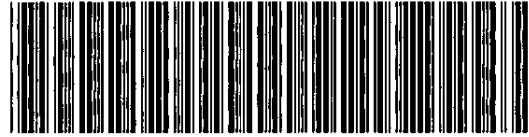



ARTICLE I--NAME and PRINCIPAL PLACE OF BUSINESS

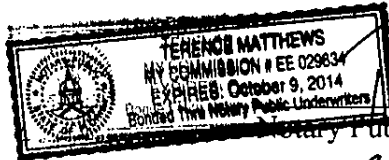


