1. Article V of the Articles of Organization is hereby amended as follows:

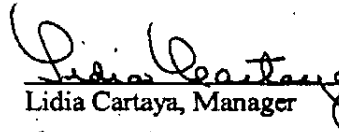

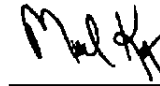
2. The date of adoption of the amendments is August 3, 2012.

4. The amendments were adopted by the unanimous consent of the members.


