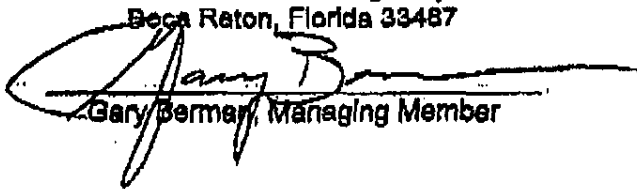

ARTICLE VI-MEMBERS RIGHT TO CONTINUE BUSINESS

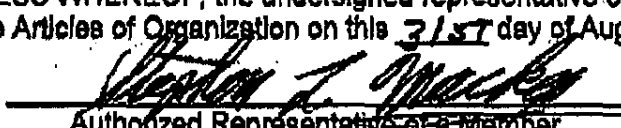

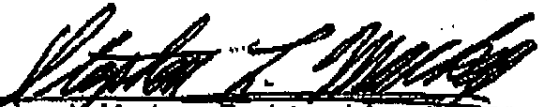
