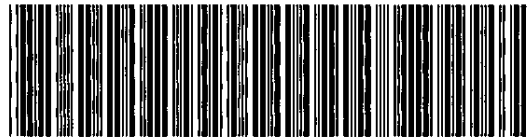

Palm City, FL 34990.

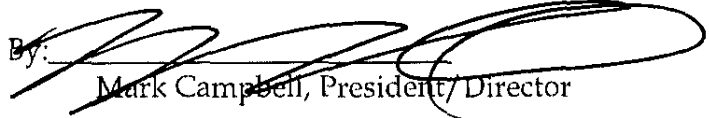
SECOND: The date of the amendment's adoption is July 2, 2012.
