ARTICLE IV

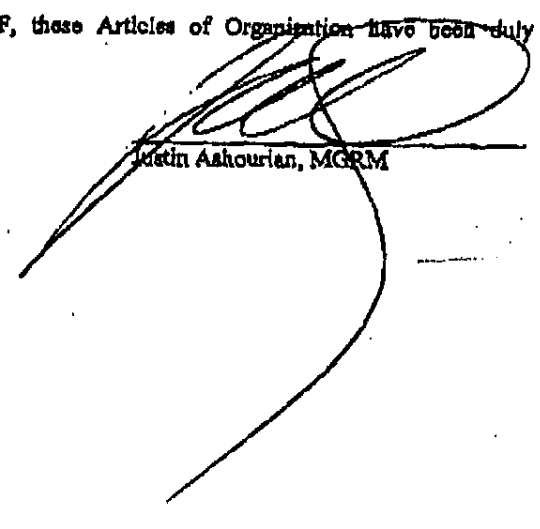

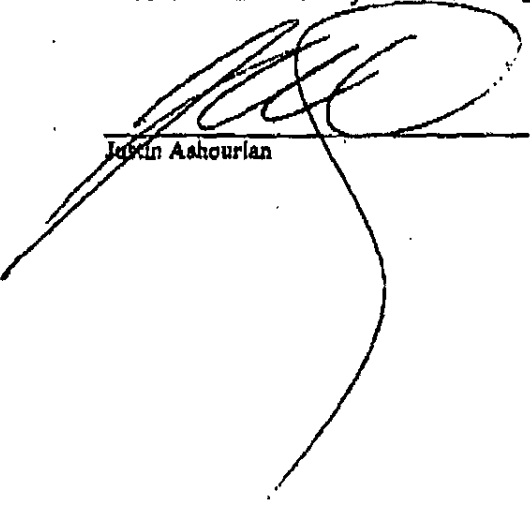
