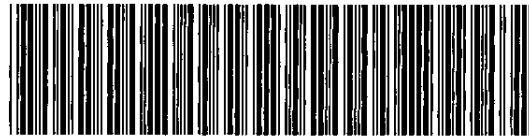




Management by Members




