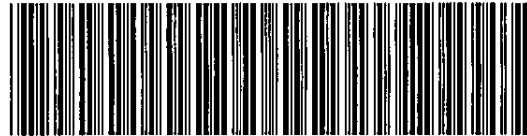




**Article IX – Oath of Incorporator and Registered Agent**
