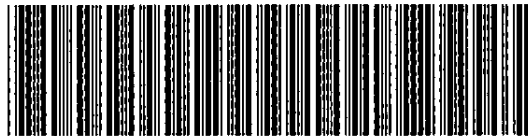

The name of the Limited Liability Company is 224 HOLDINGS, LLC (the "Company").


