ARTICLE VII - ADMISSION OF ADDITIONAL MEMBERS

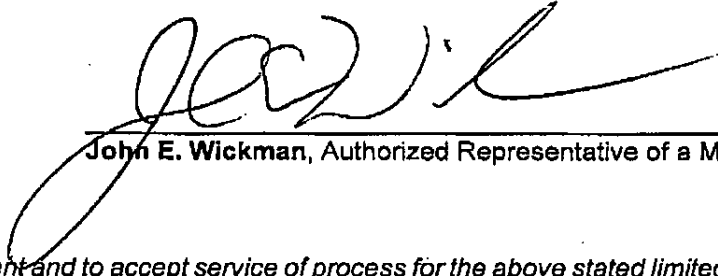

ARTICLE IX - EFFECTIVE DATE

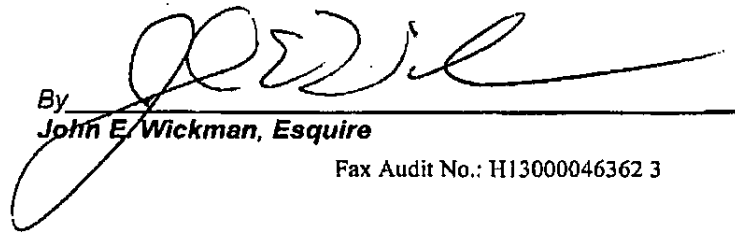
