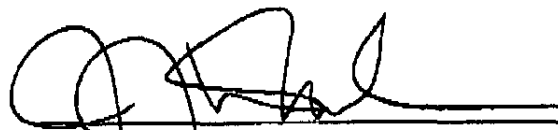
ARTICLE IV

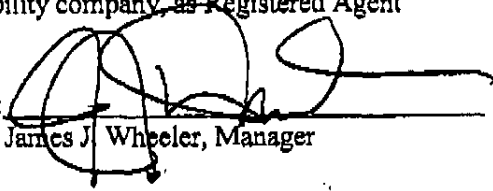
