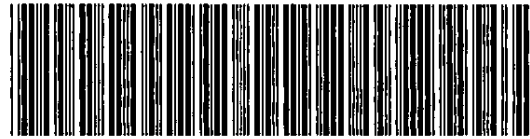

**Articles of Amendment to Articles of Incorporation of  
Sheep Not Goats Inc.  
Document # N13000000571**

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment(s) to its Articles of Incorporation:

**A. Amendment to Article III (purpose of corporation)**

Sheep Not Goats Inc. is organized exclusively for the following charitable and education purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future US federal tax code:

- To provide relief of the poor, distressed, and underprivileged in the town of Malpaisillo, Nicaragua and surrounding area through development and operation of a not-for-profit agricultural enterprise (farm) that will provide income to the poor and improved food access.
- To offer educational support within the community by teaching English as a second language as well as offering education support in other subject areas, as needed
- To provide other non-partisan and charitable services as approved by the Board of Directors, within the boundaries defined in Article I, Section 3 of the bylaws.

**B. Amendment to Board of Directors (originally defined in Article VII)**

The Officers and/or Directors are amended as indicated below, indicating the title and name of each officer/director being removed and title, name, and address of each Officer and/or Director being added, and indicating each officer/director title by the first letter of the office title:

P = President; V= Vice President; T= Treasurer; S= Secretary; D= Director; TR= Trustee; C = Chairman or Clerk; VC = Vice Chairman; CEO = Chief Executive Officer; CFO = Chief Financial Officer.

**C. Article IX (New)**

DISSOLUTION OF THE CORPORATION - Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**D. Article X (New)**

The following aspects of corporate governance and operations are to be conducted in accordance with bylaws for Sheep Not Goats Inc., and all changes to those bylaws must be approved by a two-thirds majority of board members.


1. Changes to board of directors membership, responsibilities, compensation, due diligence, and duty of loyalty
2. Frequency, duration, and minimum agenda topics for board of director meetings
3. Statement of corporate mission/purpose as currently defined in Article III
4. Code of ethics and whistleblower policies
5. Transparency policy, including but not limited to Form 990, annual reports, financial statements, and the SheepNotGoats.org public website
6. Compensation practices
7. Document retention policy
8. Other aspects of the corporation that are added to corporate bylaws in the future by the board of directors
