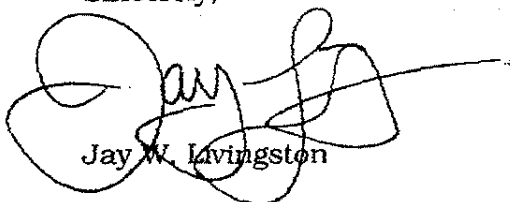
Thank you for your email dated October 24, 2013 advising that the Electronic Articles of Organization for COMIN' AROUND AGAIN, LLC could not be filed because the company's name is not available. As you discovered there is a corporation registered under the name COMIN AROUND AGAIN, INC. that is not distinguishable from the name we attempted to register under. There are no other entities that have similar or indistinguishable names in the database.

My clients recently purchased all of the assets of COMIN AROUND AGAIN, INC., including the name and goodwill, with the closing occurring on October 24, 2013. I have enclosed signed copies of the contract, corporate resolution authorizing the same and the bill of sale. As you will see in the contract and the bill of sale the name "COMIN AROUND AGAIN" and "COMIN AROUND AGAIN, INC." were transferred to my client. In addition, on October 27, 2013 the owners of COMIN AROUND AGAIN, INC. filed articles of dissolution voluntarily dissolving the corporation as required by the contract. A copy of the articles of dissolution are also

enclosed. I believe the enclosures satisfy the requirements of Section 608.406(2), Florida Statutes, allowing you to file the Articles of Organization for COMIN' AROUND AGAIN, LLC.
