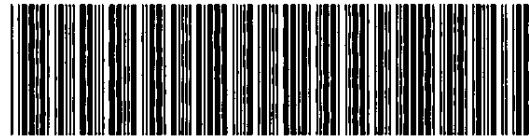

All debts, obligations, and liabilities of the Company have been paid or discharged, or adequate provision has been made herefore pursuant to §608.4421, Florida Statutes.


Article V – Distribution of Property
