- FIRST:** The name and address of this Company is **HERNANDEZ-CARDENACHE, BAQUERO, AND NEUROPSYCHOLOGY CONSULTANTS PLLC**, 15954 Northwest 79th Place, Miami Lakes, Florida 33016.
- SECOND:** The Articles of Organization were filed on October 17, 2012 and assigned document number L12000132513.
- THIRD:** The date of the adoption of these Articles of Dissolution is 5 November 2013.
- FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 608.4421.
