ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION  
OF  
RR LITTLE PARADISE, LLC  
a Florida limited liability company

The undersigned hereby establishes the following for the purpose of amending the Articles of Organization of RR LITTLE PARADISE, LLC, a Florida limited liability company (the "Company", as filed with the Secretary of State, Division of Corporations, on January 23, 2014, Document Number L14000012738, by and under the provisions of Section 605.0202, Florida Statutes, which provides for the amendment of the Articles of Organization:

1. Article II is hereby amended to read as follows:

"ARTICLE II

Unless sooner terminated by law, the Company shall have a term of existence of thirty (30) years from January 23, 2014, which is the date that the Articles of Organization were originally filed with the Florida Department of State."

2. This amendment to the Articles of Organization was adopted on the 24<sup>th</sup> day of January, 2014 by the sole Member of the Company.

3. This Amendment is effective as of the date hereof.

4. In all other respects, the Articles of Organization shall remain in full force and affect.
