Article IX - Purpose

Pom Mom Rescue, Inc. is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. More specifically, to provide rescue and sanctuary services for animals.

Article X - Dissolution

Upon the dissolution of Pom Mom Rescue, Inc., assests shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assests not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes. More specifically, in the event of dissolution of Pom Mom Rescue, Inc., for any reason whatsoever, all funds and property of the Rescue, remaining after payment of debts shall go to a charitable organization with purposes the same or similar to those of the Rescue.
