Pursuant to section 617.1403, Florida Statutes, South Florida 2017 CFCG Host Committee, Inc., a Florida nonprofit corporation, desires to dissolve its corporate status, and hereby submits the following Articles of Dissolution:

ARTICLE I - NAME OF CORPORATION

The name of the corporation as currently filed with the Florida Department of State is South Florida 2017 CFCG Host Committee, Inc. (hereinafter referred to as the "Corporation"). The document number of the Corporation is N13000010870 .

ARTICLE II - EFFECTIVE DATE

The effective date of the dissolution of the Corporation shall be February 10, 2014.
