**ARTICLES OF INCORPORATION
OF
AVP FRONTLINE, INC.**

The undersigned, acting as incorporator of a business corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such business corporation.

ARTICLE I - CORPORATE NAME

The name of the Corporation shall be:

AVP FRONTLINE, INC. (the "Corporation").

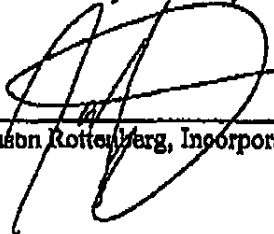

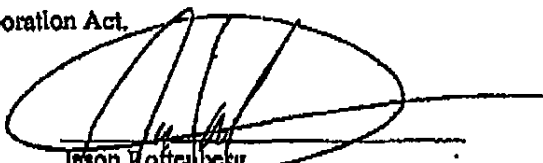
