**RESTATEMENT OF
ARTICLES OF ORGANIZATION
OF

The Articles of Organization of Maitland City Center, LLC, a Florida limited liability company (the "Company"), were filed with the Florida Department of State on March 3, 2014. Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act (the "Act"), the Articles of Organization of the Company are hereby restated in their entirety to read as follows:

ARTICLE I - NAME

The name of the Company is Maitland City Center, LLC.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - INITIAL REGISTERED AGENT


