The undersigned, acting as Incorporator of a Florida corporation ("Corporation") the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, causes to be delivered the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME

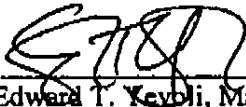
ACCEPTANCE OF DESIGNATION AS REGISTERED AGENT
