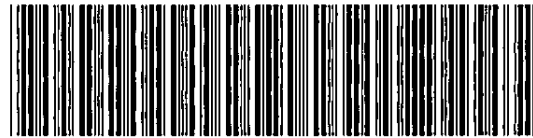

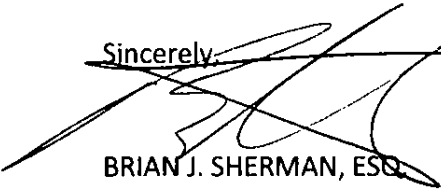

RESOLUTION NO. 14-03-26-02

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE NORTH BROWARD HOSPITAL DISTRICT ("DISTRICT") AUTHORIZING THE DISSOLUTION OF HEALTHCARE EDUCATION PLUS, INC., A NOT-FOR PROFIT CORPORATION IN WHICH THE DISTRICT IS THE SOLE MEMBER; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Healthcare Education Plus, Inc. (HEPI) was formed by the District in 1988; and,

WHEREAS, as HEPI have been idle since at least 2010, and was reinstated with the State of Florida, Division of Corporations to resolve its affairs; and

WHEREAS, with such affairs have been resolved, it is in the best interest of the District to formally dissolve HEPI.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE NORTH BROWARD HOSPITAL DISTRICT THAT:

Section 1. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

Section 2. The Board of Commissioners of the North Broward Hospital District, as the sole member of HEPI, authorizes and approves of the dissolution of HEPI.

Section 3. District staff and legal counsel are authorized to take all steps necessary to effectuate the intent of this Resolution.

Section 4. All resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed to the extent of such conflict.

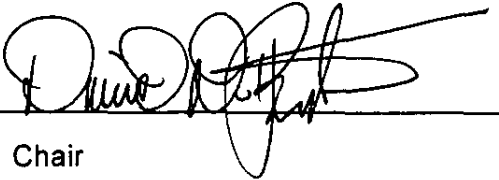
Section 5. If any clause, section, or other part or application of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part or application shall be considered as eliminated and so not affecting the validity of the remaining portions or applications remaining in full force and effect.

Section 6. This Resolution shall become effective immediately upon its passage and adoption.

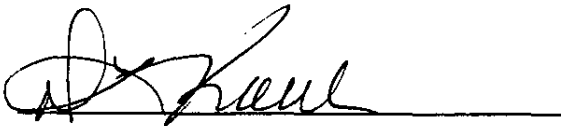

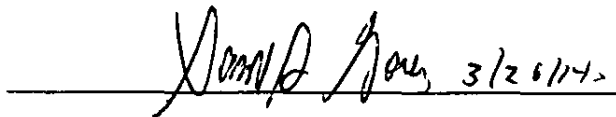

PLAN OF DISTRIBUTION OF ASSETS

This Plan of Distribution of Assets is made and entered into by Healthcare Education Plus, Inc., a Florida not for profit corporation ("HEPI"), to be effective as of _____, 2014.

WHEREAS, it was determined by the Board of Directors of the Corporation that it would be in its best interest to dissolve as a Florida not for profit corporation in accordance with the laws of the State of Florida; and

WHEREAS, in connection with such dissolution and in accordance with the requirements of Section 617.1406, Florida Statutes, HEPI desires to enter into this Plan of Distribution of Assets; and,

WHEREAS, the HEPI's Board of Directors has approved and authorized this Plan of Distribution of Assets by Resolution.

NOW, THEREFORE, in consideration of the premises above and intending to be legally bound hereby, the following is adopted as a Plan of Distribution of Assets for the purpose of properly distributing all assets, liabilities and obligations of the HEPI.

1. The assets of the HEPI shall be distributed in accordance with Article IX of the Articles of Incorporation to the North Broward Hospital District, a political subdivision of the State of Florida as described in Section 170(c)(1) of the Internal Revenue Code, and a 501(c)(3) organization as described in the Internal Revenue Code.
2. All obligations and liabilities of HEPI have been satisfied and discharged. Should any funds remain after closeout, the remaining funds shall be distributed to North Broward Hospital District.
3. The officer signing below hereby certifies the HEPI's compliance with Section 617.1406(2), Florida Statutes.

By signing below, such officer hereby authenticates this Plan of Distribution of Assets.
