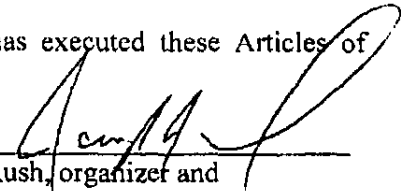
**ARTICLE IV

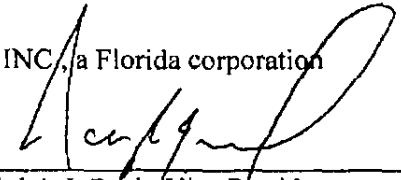
