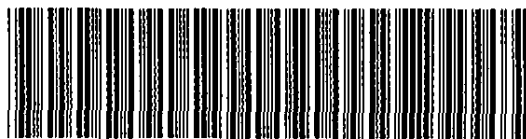

The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 and the Florida Professional Service Corporations Act, Chapter 621 of the Florida Statutes, hereinafter referred to as the Corporation, hereby agrees to the following:

**ARTICLE I - NAME**

The name of the Corporation shall be ANDREW ROTHBERG, O.D., P.A.

**ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS OF CORPORATION**

**ARTICLE VI – REGISTERED AGENT**

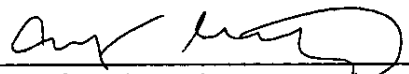
