CERTIFICATE OF AMENDMENT TO THE BY-LAWS AND ARTICLES OF INCORPORATION OF 500 BRICKELL WEST, A CONDOMINIUM

The undersigned being the President of the 500 Brickell West, a Condominium, located in Miami Dade County, Florida, the Declaration of Condominium having been recorded in the Official Records Book 26352, at Page 3500 of the Public Records of Miami Dade County, Florida, do hereby certify that a duly noticed meeting of the members of 500 Brickell West Condominium, held on August 6, 2014, where in accordance where the required percentage of the Voting Members present at the meeting in person approved the following amendment to the By-Laws and Articles of Incorporation of 500 Brickell West Condominium Association, Inc., in accordance with the provisions of Section 13 of its By-Laws and Article 13 of its Articles of Incorporation. (New language is indicated by underscored type, old language is indicated by lined type).

The foregoing Amendment shall be effective as of the date of recordation of this Certificate in the Public Records of Miami-Dade County, Florida. Except as specifically amended hereby, the Declaration shall remain in full force and effect ab initio.

- 1. Section 4.1 of the By-Laws shall be amended as follows:
 - 4. Directors.
 - 4.1 Membership. The affairs of the Association shall be governed by a Board of not less than three (3) nor more than nine (9) directors, the exact number to be determined in the first instance in the Articles, and, thereafter, except as provided herein, from time to time upon majority vote of the membership. Directors must be natural persons who are 18 years of age or older, and must be members of the Association. Any person who has been convicted of any felony by any court of record in the United States and who has not had his or her right to vote restored pursuant to law in the jurisdiction of his or her residence is not eligible for Board membership (provided, however, that the validity of any Board action is not



affected if it is later determined that a member of the Board is ineligible for Board membership due to having been convicted of a felony). Directors may not vote at Board meetings by proxy or by secret ballot.

2. Section 10.1 of the Articles of Incorporation shall be amended as follows:

10.1 Number and Qualification. The property, business and affairs of the Association shall be managed by a board consisting of the number of directors determined in the manner provided by the By-laws, but which shall consist of not less than three (3) directors nor more than nine (9) directors. Directors <u>must need net</u> be members of the Association.
