Pursuant to section 617.1403, Florida Statutes, Gulliver Schools Foundation, Inc., a Florida nonprofit corporation, desires to dissolve its corporate status, and hereby submits the following Articles of Dissolution:

**ARTICLE I - NAME OF CORPORATION**

The name of the corporation as currently filed with the Florida Department of State is Gulliver Schools Foundation, Inc. (hereinafter referred to as the "Corporation"). The document number of the Corporation is N05000004978.

**ARTICLE II - EFFECTIVE DATE**


The effective date of the dissolution of the Corporation shall be effective on the date filed with the Secretary of State of the State of Florida.

**ARTICLE III - APPROVAL**

The Corporation has one (1) member which is not entitled to vote on the dissolution. The Board of Directors of the Corporation adopted a resolution for dissolution on October 17, 2014. The number of members of the Board of Trustees then in office was four (4) and the vote for the resolution was unanimous in favor of dissolution.
