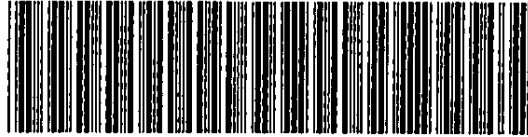

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: (1) To train qualified dogs to perform specific tasks required by the special needs community and place those dogs with qualified clients to improve the clients mobility and/or their quality of life; (2) To raise funds for the purchase of qualified dogs and all necessary equipment required for their individual training; (3) To raise funds to educate the public and business owners on the requirements of the Americans with Disabilities Act (ADA) and Florida State Law as they pertain to service dogs; (4) To provide qualified clients of Service Dog University, Inc. (SDU, Inc.) with one-on-one training on the handling and continued training of their partner dog; and (5) To educate SDU, Inc. clients concerning licensing, vaccination, and care requirements of their partner dogs.

ARTICLE IV MANNER OF ELECTIONS The manner in which the directors are elected and appointed: The initial Board of Directors is to be elected a majority vote of the volunteers present at a general meeting. Vacancies on the Board of Directors shall be filled by the Board, with recommendation of the Chairman.
