Articles of Incorporation

Grace Anglican Church, Inc.

The undersigned, being a director of Grace Anglican Church, Inc., a Florida Not For Profit Corporation does hereby certify as follows:

That pursuant to the provisions of section 617.1007, Florida Statutes, this Florida Not For Profit Corporation adopts the following in its entirety as its Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation shall be Grace Anglican Church, Inc.

ARTICLE II - PRINCIPAL OFFICE

375 Thistledown Way, The Villages, Florida 32162.

ARTICLE III - PURPOSE

The purpose for which the corporation is organized is:

This Corporation is a religious non-profit corporation organized for the purpose of furthering the worship of Almighty God according to the faith and discipline of the United Episcopal Church of North America; of the transaction of any and all lawful business needful in the conduct and regulation of the temporal affairs of this Congregation; and of supporting, promoting, and carrying forward such religious and charitable activities as are consistent within the meaning of Sections 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue laws (the "Code") and the Statutes of the State of Florida. More particularly, the corporation is organized to operate as a public charity within the meaning of Section 509 (a) (3) of the Code in order to perform the functions of and to carry out the purposes of the Anglican Church

ARTICLE IV - DURATION

This Corporation is to exist perpetually.

ARTICLE V - MANNER OF ELECTION

The manner in which the directors of the board of directors are elected shall be set forth in the bylaws of the Corporation.

ARTICLE VI - USE OF FUNDS

No part of the net earnings of the corporation shall be distributable to or inure to the benefit of its officers or directors or any private person, except that the corporation shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its exempt purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision hereof, the corporation shall not carry on any other activities not permitted to be carried on (1) (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Code or (2) by a corporation to which contributions are deductible under Section 170 (c) (2) of the Code.

ARTICLE VII - DISTRIBUTION UPON DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such asset not so disposed of by a court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine which are organized and operated exclusively for such purpose.

ARTICLE VIII - REGISTERED AGENT


