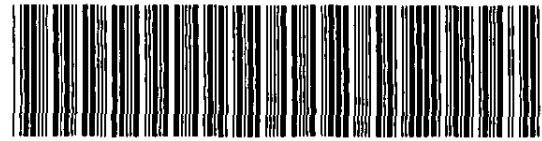

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **POSITIVECARRY LLC** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 2520 Southwest 22nd Street, Suite 2, PMB 381-H1637, Miami, Florida 33145 and the mailing address shall Post Office Box 557601, Miami, Florida 33255.

ARTICLE 3 - EFFECTIVE DATE




