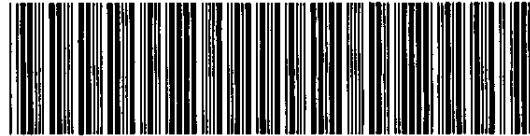

TO

The name of this corporation shall be SHAPIRO, BLASI, WASSERMAN & HERMANN, P.A.

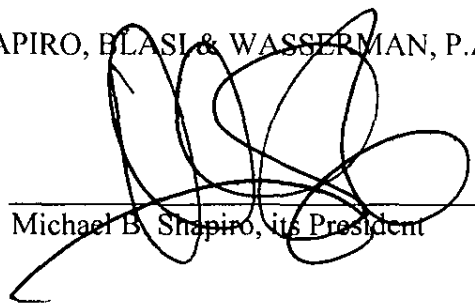
3. This Amendment was recommended by the Board of Directors to the Corporation's shareholders on April 15, 2015.
