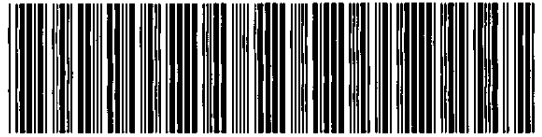

**ARTICLE III- Management**




