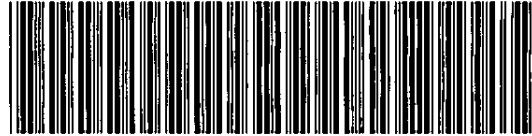

"ARTICLE IV CAPITAL STOCK

The aggregate number of shares which the Corporation shall have authority to issue is two trillion (2,000,000,000,000) shares of common stock, par value \$.00001 per share.

Effective upon the "Effective Date" (as defined below), the outstanding shares of common Stock of the Corporation shall be increased on a basis of one thousand (1,000) of such shares of common stock for every one (1) share held on the Effective Date, without changing the par value of the shares of the Corporation, (the "Forward Split"); provided that no fractional shares of the Corporation shall be issued in connection with the Forward Stock Split and the number of shares to be received by a stockholder shall be rounded up to the nearest whole number of shares in the event that such stockholder was otherwise entitled to receive a fractional share as a result of the Forward Split.

The "Effective Date" shall be the first date permitted or determined by the Financial Industry Regulatory Authority (FINRA) as the effective date of such Forward Stock Split, subject to the prior filing and recording of this Articles of Amendment in the office of the Florida Department of State Division of Corporations."
