The name of the limited liability company shall be **BUENA VISTA DISTRICT LLC** ("Company").

ARTICLE 2 - ADDRESS

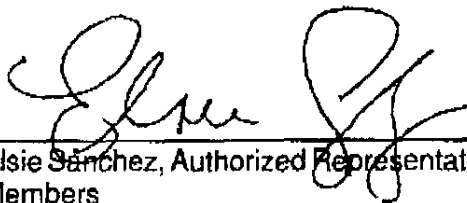

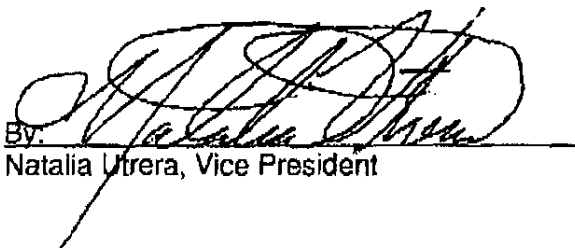
