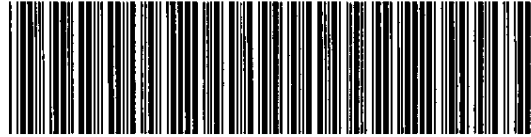


ARTICLE I - Name

The name of the Limited Liability Company is: 2201, LLC."



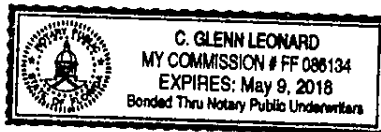
