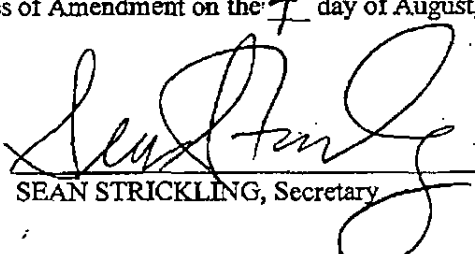
1. Name of Corporation: SUNCOAST REHABILITATION CENTER, INC.
