AMENDING ARTICLE III. PURPOSE. THE FOLLOWING SHALL BE ADDED TO ARTICLE III. PURPOSE,
AS APROVED BY VOTE ON OCTOBER 30, 2015.

5. To further identify its function and purpose, RMI (Revelation Ministires International, Inc.) as a church, this congregation is organized as a church exclusively for charitable, religious, and educationalal purposes within the meaning of Section 501(c)3 of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law), for such purposes including, but not limited to, the proclaiming of the Gospel of the Lord Jesus Christ; the establishing and maintaining of feligious worship; the educating of believers in a manner consistent with the requirements of Holy Scripture; the issuing of ministerial and Biblical counseling research and therapies, and the maintaining of missionary activities in the United States and any foreign country.

The RMI Fellowship is a church that functions on a local, national, and international level to disseminate the Gospel of Jesus Christ and for the expansion of the Kingdom of God. The local church is the main church campus and functions as a denomination or ministerial fellowship that provides training, equipping, experience and credentialing to ministers. On the national level the RMI Fellowship is quipping and working with missionaries and other minisitries and groups to lead out-reaches, church plants that may function as extension campuses or as independent churches, chaplain programs, provide passtoral care and other ministries. Internationally, the RMI Fellowship trains, equips, supports, and partners those individuals and organizations who can further the purposes of this church.

The RMI Fellowship currently meets at 1100 Campbell Avenue, Jacksonville, FL, and this property is maintained for the sole prupose of the fellowship. The fellowship may relocate and or add additional places of worship at its discretion.

RMI maintians that "fellowship", "gathering", "congregation", "church" are mutually defined by Holy Scriptures as having the same meaning and purpose, and RMI has adopted Articles Of Faith, which define the belief and purpose of the fellowship according to Holy Scripture, and which are attached to this Article (III. PURPOSE) as tiem 6.

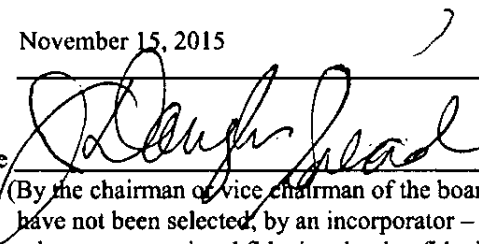
