Pursuant to Section 607.1105 of the Florida Business Corporation Act (the "FBCA"), these Articles of Merger provide as follows:

ARTICLE I

State of Incorporation; Surviving Corporation

The name and state of incorporation of each of the constituent corporations of the merger is as follows:

The Board of Directors of Pleasant Kids, Inc., reviewed, considered and, on December 28, 2015 pursuant to an action by unanimous written consent in accordance with Section 607.0821 of the FBCA, duly adopted the Agreement and Plan of Merger, and presented the Agreement and Plan of Merger to the sole shareholder of NGH Acquisition Corp. In accordance with Section 607.1101 of the FBCA. Thereafter, the sole shareholder of NGH Acquisition Corp adopted and approved the Agreement and Plan of Merger on December 28, 2010 pursuant to an action by written consent in accordance with Section 607.0704 of the FBCA
