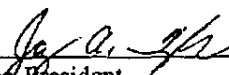
**NOW THEREFORE**, the Corporation's Articles of Incorporation are amended as follows:

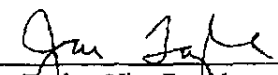
Article 1 is deleted and inserted in its place shall be:
