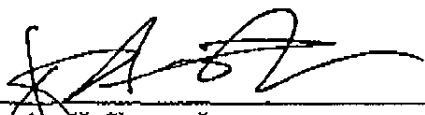
ARTICLE VI - INCORPORATOR
