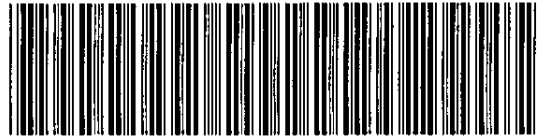

No person may be admitted as a member of this Limited Liability Company unless each existing member consents in writing to the admission of such additional member.

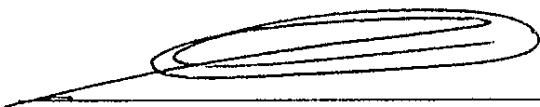
ARTICLE IX – CONTINUATION OF BUSINESS OPERATIONS
