The street address and the mailing address of the principal office of the Company are 4145 Venetia Boulevard, Jacksonville, Florida 32210.

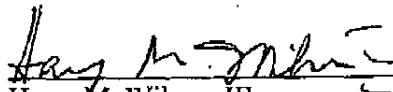

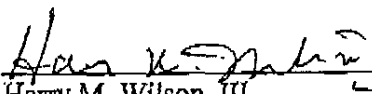
