Articles of Incorporation Of

(In Compliance with Chapter 617, F.S., Not for Profit)

Article 1.

The name of the corporation is Young At HARP, Inc.

Article 2.

The initial registered office of the Corporation shall be at: 77 Bayhead Ln, Osprey, FL 34229. The initial registered agent of the Corporation at such address shall be: Raymond Murphy.

Article 3.

The name and address of the incorporator is:

Article 4.

The initial principal office address of the Corporation shall be at: 77 Bayhead Ln, Osprey, FL 34229.

Article 5.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The specific purpose of the organization is to support children's hospitals by playing and tutoring harp.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
