ARTICLE V. MANAGEMENT

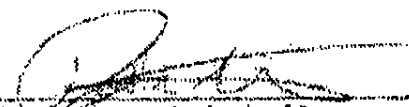
The Company shall be a manager-managed company, and the managers of the Company shall be designated in accordance with the Operating Agreement of the Company.

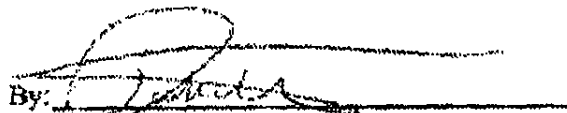
