The mailing address and principal place of business of the Company is 133 Sevilla Avenue, Coral Gables, Florida 33134.

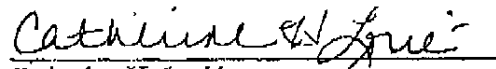

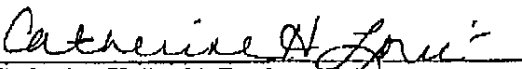
