ARTICLE THREE

SECTION 10. To purchase, rent, lease, acquire, own, hold in trust, use, sell, convey, mortgage, or otherwise dispose of any real estate or chattels as may be necessary for the stated purposes; to hold properties for investments of said funds; to hold in trust properties for the stated purposes. All activities occurring within or upon said properties shall be those led or approved of by the Holy Spirit.

ARTICLE FOURTEEN

REQUIREMENTS FOR MINISTERS and CORPORATE MEMBERS

SECTION 6. Ordained or licensed ministers may perform marriage ceremonies for one man to one woman as confirmed by the Holy Spirit in prayer. His love never changes regardless of whether or not persons trust His word as revealed in Holy Scripture. Our response must always originate from His heart of love for each person. Therefore, our goal will always be that each person hears for themselves the truth of God that sets them free.

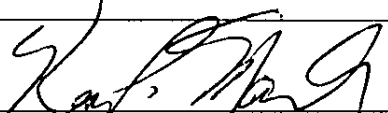
